### **Election of 16 (sixteen) Council Members for the 18<sup>th</sup> Council of the Institute for the term 2023 – 2025**

This is for kind information of all esteemed members of the Institute that as per Probidhan 5(1) of the "Cost and Management Accountants Probidhanmala, 2019" and subsequent amendment vide S.R.O. No. 343-Law/2022 dated November 22, 2022, the 18<sup>th</sup> Council Election of the Institute will be held on **December 28, 2022** for regional voters at **Chattogram Centre** (CMA Bhaban, CDA R/A, Agrabad, Chattogram) and on **December 30, 2022** for central voters at **Dhaka Centre** (ICMA Bhaban, Nilkhet, Dhaka) to elect 16(sixteen) Council Members including 1 (one) Regional Representative from Chattogram Division for the term **2023 – 2025**.

2. Voters shall vote physically coming to the voting centres or alternatively they can vote online by login into "My ICMAB" using **Google Chrome web browser** located at the top right corner of the ICMAB website [www.icmab.org.bd](http://www.icmab.org.bd).

3. As per Probidhan 12(1), if any member of the Institute wishes to contest the election, the nomination papers in **Form "KA"** shall be submitted to the Commission, within 10 (ten) days of publication of the voter list in accordance with Probidhan 10(1) [voter list uploaded in ICMAB website]. As per Probidhan 12(2), the nomination of a candidate shall be proposed by 1 (one) member and seconded by 2 (two) members of the Institute eligible for voting in the Council Election. As per Probidhan 12(3), at the time of submission of **Form 'KA'** to the Commission, (i) an undertaking in **Form "KHA"**, (ii) 1(one) copy of photograph and (iii) a short Bio-data in **Form "GA"** shall be attached.

4. Members of the Institute are, therefore, requested kindly to nominate candidates from amongst the Fellow members of the Institute published in the Voter List using **Form-"KA"** along with (i) an undertaking in **Form "KHA"**, (ii) 1(one) copy of photograph and (iii) a short Bio-data using **Form "GA"** (copy of Forms enclosed) for election to the 18<sup>th</sup> Council and to send the same to the Institute addressing the undersigned on or before **December 09, 2022** during office hours.

5. Mirza Mostafa Walid, Executive Director (CC) and in his absence Mr. Mohammad Abdur Rahim Mahmud, Deputy Director (Admin) of the Institute will receive the Nomination Papers and issue acknowledgement receipts on behalf of the undersigned.
